

## **Order No. 133/2025**

of the Rector of Jan Kochanowski University of Kielce

dated 01 August 2025

### **on the appointment of the Gender Equality Plan Committee of the Jan Kochanowski University of Kielce**

Pursuant to Article 23(1) and (2)(2) of the Act of 20 July 2018 – Law on Higher Education and Science (Journal of Laws of 2024, item 1571, as amended) and Article 28(1)-(2), § 29(2) of the Statute of the Jan Kochanowski University, the following is hereby ordered:

#### § 1
